Lori Taylor (parent) spoke about her concern about the unannounced “Shooter” Drill that took place on October 13th. Ms. Taylor explained how frightened her 4th grader and 2nd grader were. She heard that three little girls were under the desk and how they cried with fear together. She felt that they were not capable under that kind of stress. There were comments on Face book about what’s going on in the school. It was scary for Lori as well as to her children. There were rattling on the windows and on the doors that frightened her children. It was traumatic. Mrs. Rohrig explained that our training started back in August. Our teachers and staff were trained in County wide procedures to follow including unannounced protocol. We are going to install black out curtains that other schools are installing and this is what all the other schools are doing.

Her questions were answered by Sheriff William Ponce about the unannounced drill to prep the students and staff for the real thing. He assured that the students and staffs are Safe. The deputies are going to conduct drills.

Mrs. Rohrig indicated that our 1st to the 3rd lock down drills have improved dramatically.

Ms Taylor suggested that maybe the parents should be able to opt out.

Ramona Heschke suggested that the training procedures should be walked through.

Sheriff William Ponce suggested to conduct two drills a year that are notified.

Mrs. Rohrig will notify when Lock down start and when it’s over along with the unannounced Class DoJo and Face Book, website link. We’ll notify the school Board Members.
